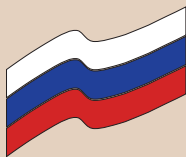

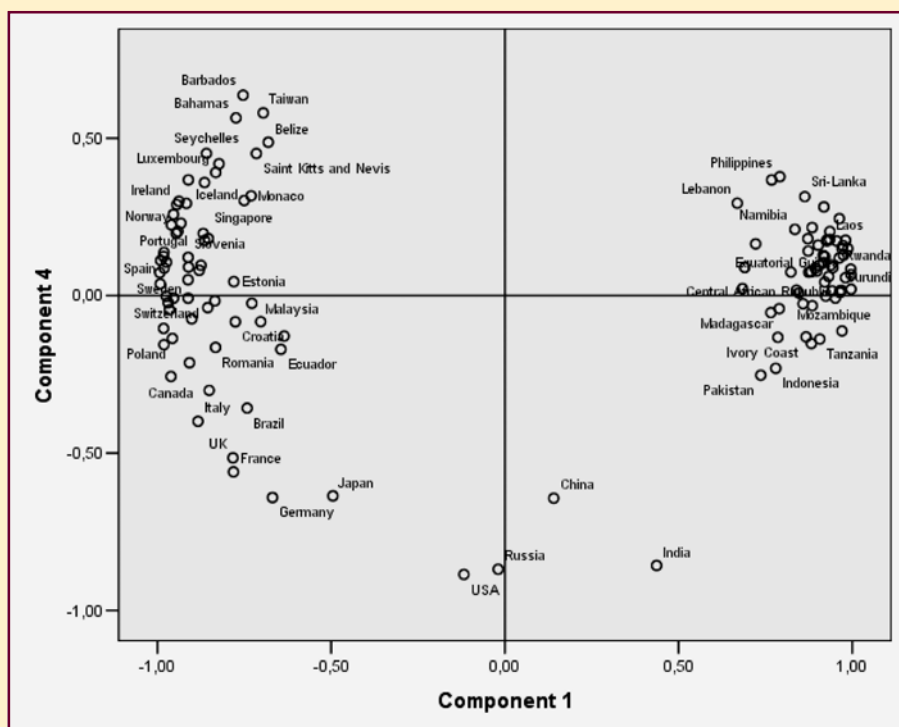
How can such unique phenomena of world politics as contemporary states be compared with each other? When comparing the states of today's world, how can one take into account the peculiarities of their history and culture, the problems and challenges they face, their levels of development and trajectories of evolution? Which role can quantitative methods play in the analysis of political systems and political regimes of modern states?

In an attempt to answer these questions, the authors of the project have developed a system of five complex indices, which makes quantitative measurements and comparisons possible:

1. index of stateness;
2. index of internal and external threats;
3. index of international influence potential;
4. index of quality of life;
5. index of institutional basis of democracy.

Based on these five indices, the corresponding ratings of all countries of the world were calculated. In this process (based on the method of principle components) four principle components were developed, each of which constitutes a specific projection of political reality of the world:

- the projection of national survival and its quality (which is effective at describing more than half of all differences between countries);
- the projection of state basis of democracy (effectively describing more than 1/4 of all differences between modern states);
- the projection of “human price” of statehood (slightly more than 10% of differences between countries);
- the projection of maximizing international influence in contemporary world (describes 7% of dispersion).



Cluster analysis was also employed as part of the project to identify certain groups (clusters) of states on a variety of grounds: the “leader-loser” scale, peculiarities of their development, problems they face, and so on.

MGI-classification:

knowledge management in international relations

MGI-classification (MGI = mnemonics-generated index) is an innovative system for comprehensive classification of research and educational activities. The product is being developed by the experts of MGIMO-University Internet Politics Center (www.netpolitics.ru).

Applications for research and educational field

Planning research and educational activities, identifying priorities of research activities and estimating their effectiveness:

- Identification of priority directions for research
- Adjusting organizational structure and staff resources, developing education plans and standards in line with established priorities in educational and research activities;
- Unified coding system;
- Clear link between printed works and opinions about them – when offline publications are categorized, a website is automatically created for related texts, annotations, reviews and comments.

Unlike traditional systems for information retrieval, MGI-classification offers the following advantages to individual user:



How does the official status in science correlate with citation index?

Whose works are really read and how much?

How often is a particular work cited and quoted?

Which are the internal social connections of various scientific groups?

Which directions of research are popular and yield new knowledge, and which are just popular and don't contribute to the pool of scientific knowledge?

- Direct retrieval of relevant information by indicating URL (web address) – no search engines are needed;
- Simple to remember MGI-codes;
- Creating a personal “information portfolio”, mapping professional competence of student and graduate, where grades received in courses can be included as weight coefficients of the neuro-network matrix.

Structure

Codes

The basis of MGI-classification is a system of mnemonic codes, which describe the main areas of a particular subject fields (in this case: international studies).

Creating a URL

MGI-classification allows for automatic generation of URL address for the object described (based on a few rules for the object code).
